ADBLUE FUELING @ HHH DEPOTS

Only acquire/purchase Adblue from Service Stations when you are travelling abroad.

Oversize and/or Overmass (OSOM) vehicles wider than 5.9m must contact 0428 386 931 at least 3 days prior travel to arrange assistance with the project team and Call-Up UHF CH 19 on approach to the worksite. These vehicles may be required to stop at designated stopping bays either side of the worksite and follow signage prior to travelling through the work zone.
